**WHEREAS**, a recommended budget including amendments (as attached) for FY 2019 has been developed and presented by the County Administrator, all in accordance with the budget policies previously adopted by this County Board; and

**WHEREAS**, it is necessary for the County Board to adopt an annual budget and appropriation in accordance with State of Illinois Law; and

**WHEREAS**, the proposed FY 2019 budget, inclusive of all revenues and expenses, including the 2018 Tax Levy to be collected during FY 2019, has been reviewed and acted upon by the Standing Committees of the County Board; and

**WHEREAS**, the recommended FY 2019 Budget has been made conveniently available for public inspection for at least fifteen days prior to adoption by posting in the Office of the County Clerk and on the County website at [www.lakecountyil.gov](http://www.lakecountyil.gov).

**NOW, THEREFORE, BE IT ORDAINED**, by this County Board of Lake County, Illinois, that

1. The Fiscal Year 2019 recommended Annual Budget and Appropriation for Lake County Illinois, for Fiscal Year 2019 was brought before the Finance and Administrative Committee, with the first such presentation occurring October 23, 2018; and
2. That the Fiscal Year 2019 recommended Annual Budget and Appropriation for Lake County, Illinois, for Fiscal Year 2019, as attached hereto and made part of, is hereby approved.
