Joint resolution accepting the Susan G. Komen Foundation grant and authorizing an emergency appropriation in the amount of \$7,300 for the Illinois Breast and Cervical Cancer program.

- The \$7,300 Susan G. Komen grant will be used to provide screening mammograms to uninsured women.
- The \$7,300 in additional grant funding has not been previously appropriated because the grant resources were secured after the County's adoption of the fiscal year 2019 budget.
- The grant award will be for the period January 1, 2019 through December 31, 2019.

## RESOLUTION

**WHEREAS**, the Lake County Health Department and Community Health Center has received a grant increase delivered by our Clinical Operations Unit; and

**WHEREAS**, these dollars will provide a legitimate increase in services to Lake County with no impact on local taxes; and

**WHEREAS,** this grant amount totaling \$7,300 has not been previously appropriated, having been awarded after adoption of the FY 2019 budget; and

**WHEREAS**, the proposed appropriation will be fully offset by the above referenced items thereby not requiring the expenditure of local tax revenue.

**NOW, THEREFORE, BE IT RESOLVED,** by this County Board of Lake County, Illinois, that an emergency appropriation in the amount of \$7,300 is hereby authorized in the Health Department budget as identified on the listing of expense and revenue budget modifications attached hereto and

made part hereof; and

**BE IT FURTHER RESOLVED**, that the revenue budgets as identified on the attached listing be modified as provided by increased funding from the following:

Susan G. Komen Foundation - Illinois Breast and Cervical Cancer Program, \$7,300.
