Joint resolution authorizing an emergency appropriation in the amount of \$45,000 in funding from the Illinois Department of Healthcare and Family Services and the approval of the renewal of Intergovernmental Agreement No. 2018-55-024-KD for the 19th Judicial Circuit's Access and Visitation Program for state fiscal year 2020.

- The 19th Judicial Circuit receives grant funding from the Illinois Department of Healthcare and Family Services to provide mediation services for never-married parents involved in visitation and custody-related disputes in an effort to increase child support collections from this population.
- The state would like to continue funding the 19th Judicial Circuit's program in the amount of \$45,000 for state FY 2020.
- This access and visitation grant does not require matching funds.
- From July 2017 through June 2018, this program conducted 200 mediations.

RESOLUTION

WHEREAS, the 19th Judicial Circuit entered into an agreement in state FY 2009 with the Illinois Department of Healthcare and Family Services to provide mediation services for non-married parents involved in visitation and custody-related disputes; and

WHEREAS, the Illinois Department of Healthcare and Family Services would like to continue funding the 19th Judicial Circuit's program in the amount of \$45,000 for state FY 2020; and

WHEREAS, this access and visitation grant does not require matching funds; and

WHEREAS, it is necessary to approve the new intergovernmental agreement and appropriate the \$45,000 in funding to formally accept this grant.

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that it hereby approves Agreement No. 2018-55-024-KD with the Illinois Department of Healthcare and Family Services and an emergency appropriation of \$45,000 for the 19th Judicial Circuit's Access and Visitation Program for state fiscal year 2020; and

BE IT FURTHER RESOLVED, that the \$45,000 be appropriated in account 101-3200010-71140-000-000-000-32002 with offsetting revenue to be deposited in account 101-3200010-45340-000-000-000-32002.
