Joint resolution accepting the Illinois Department of Human Services Division of Substance Use Prevention and Recovery grant and authorizing an emergency appropriation in the amount of \$8,092 for the Substance Abuse Prevention Services grant.

- The \$8,092 Illinois Department of Human Services Division of Substance Use Prevention and Recovery grant will be used for printing, postage, mileage, and supplies associated with the “Generation Rx” promotional campaign.
- The \$8,092 in additional grant funding has not been previously appropriated because the grant resources were secured after the County’s adoption of the fiscal year 2019 budget.
- The grant award will be for the period July 1, 2018 through June 30, 2019.

### RESOLUTION

**WHEREAS**, the Lake County Health Department and Community Health Center has received a grant increase delivered by our Prevention Unit; and

**WHEREAS**, these dollars will provide a legitimate increase in services to Lake County with no impact on local taxes; and

**WHEREAS**, this grant amount totaling \$8,092 has not been previously appropriated, having been awarded after adoption of the FY 2019 budget; and

**WHEREAS**, the proposed appropriation will be fully offset by the above referenced items thereby not requiring the expenditure of local tax revenue.

**NOW, THEREFORE, BE IT RESOLVED**, by this County Board of Lake County, Illinois, that an emergency appropriation in the amount of \$8,092 is hereby authorized in the health department budget as identified on the listing of expense and revenue budget modifications attached hereto and made part hereof; and

**BE IT FURTHER RESOLVED**, that the revenue budgets as identified on the attached listing be modified as provided by increased funding from the following:

Illinois Department of Human Services - Division of Substance Use Prevention and Recovery - Substance Abuse Prevention Services, \$8,092.
