- In May 2018, the Lake County Board authorized a contract with 720 Worldwide, Inc. for System Programming and Computer Operation services in the estimated amount of \$475,776 for a contract term expiring on December 2, 2019, with no renewal options.
- This contract provides for staff augmentation services to support the mainframe which hosts the current Court Records Information Management System (CRIMS).
- There is a need for these services to continue until the new Case Management System (CMS) is implemented.
