Resolution authorizing a contract with CDWG, Vernon Hills, Illinois, in an amount of \$53,109.40 to allow the remote workforce access to required work applications via Citrix Workspace.

- Citrix Workspace currently provides secure access to Lake County's remote workforce. The contract is set to expire.
- Purchasing identified an existing General Services Administration (GSA) contract that had been competitively bid and awarded to CDWG for use in purchasing any required software licensing.
- Pursuant to Article 10-101 of the Lake County Purchasing Ordinance, Cooperative Purchasing, Lake County may participate in a cooperative purchasing agreement for the procurement of goods with one or more public procurement units in accordance with an agreement entered between the participants.
- Lake County desires to enter into a contract with CDWG, for Citrix workspace licenses in the amount of \$53,109.40.
- This software was included and budgeted in Information Technology's FY 2019 Budget.

RESOLUTION

WHEREAS, in accordance with Section 10-101 of the Lake County Purchasing Ordinance, a cooperative purchasing contract with GSA to procure licenses that was competitively solicited and awarded has been identified for the purchase; and

WHEREAS, Purchasing identified a cooperative purchasing contract with CDWG, Vernon Hills, Illinois through the General Services Administration (GSA) to procure Citrix licenses;
