- Lake County's Enterprise Technology (ET) is requesting authorization to contract with MidCo for Mitel phone system maintenance and software assurance as it offers more comprehensive support.
- MidCo is a vendor whose services will be procured through a joint purchasing agreement which was competitively solicited and awarded through Sourcewell formally known as National Joint Powers Alliance (NJPA) contract number 040314.
- Article 10-101 of the Lake County Purchasing Ordinance, Cooperative Purchasing, enables
 the County to participate in a cooperative purchasing agreement for the procurement of goods
 with one or more public procurement units in accordance with an agreement entered between
 the participants.
