Joint resolution accepting the Lake County Stormwater Management Commission contract and authorizing an emergency appropriation in the amount of \$17,879 for the Removal of Carp to Reduce Nutrient Enrichment Project.

- The \$17,879 Lake County Stormwater Management Commission contract will be used for contractual services, trainings, and to offset existing salary dollars.
- The \$17,879 in additional contract funding has not been previously appropriated because the contract resources were secured after the County's adoption of the Fiscal Year 2020 budget.
- The contract will be for the period December 1, 2019 through November 30, 2021.

RESOLUTION

WHEREAS, the Lake County Health Department and Community Health Center has received a contract increase delivered by our Prevention Unit; and

WHEREAS, these dollars will provide a legitimate increase in services to Lake County with no impact on local taxes; and

WHEREAS, this contract amount totaling \$17,879 has not been previously appropriated, having been awarded after adoption of the Fiscal Year 2020 budget; and

WHEREAS, the proposed appropriation will be fully offset by the above referenced items thereby not requiring the expenditure of local tax revenue.

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that an emergency appropriation in the amount of \$17,879 is hereby authorized in the Health Department budget as identified on the listing of expense and revenue budget modifications attached hereto and made part hereof; and

BE IT FURTHER RESOLVED, that the revenue budgets as identified on the attached listing be modified as provided by increased funding from the following:

Lake County Stormwater Management Commission - Removal of Carp to Reduce Nutrient Enrichment Project, \$17,879.
