Resolution authorizing an agreement with Wold Architects and Engineers, Palatine, Illinois, for design and development of wayfinding improvements and standards for the Lake County Waukegan Campus in the amount of \$57,590.

- As part of the Fiscal Year 2020 budget process, funding was appropriated for wayfinding improvements.
- This project will establish standards for the integration of electronic directional systems into the county's existing wayfinding infrastructure.
- Implementation of this standard will improve pedestrian traffic flow to high-volume agencies located between the north County Administrative Tower and the south Babcox Justice Center of the Lake County Waukegan Campus.
- In accordance with the Local Government Professional Services Selection Act, a firm may be selected directly by the County based on a prior satisfactory relationship and the recommended consultant is Wold Architects and Engineers.

<u>RESOLUTION</u>

WHEREAS, the County wishes to improve the orderly and efficient flow of pedestrian traffic to agencies internal to the Waukegan Campus; and

WHEREAS, Lake County, has identified integration of digital directional systems as a key element of public wayfinding; and

WHEREAS, Wold Architects and Engineers has integral knowledge of the wayfinding challenges the Waukegan Campus presents via its work on prior designs; and

WHEREAS, Lake County has selected Wold Architects and Engineers in accordance with the Local Government Professional Services Selection Act, 50 ILCS 510/1 et. seq

NOW, THEREFORE BE IT RESOLVED by this Lake County Board, that the Purchasing Agent is authorized and directed to execute on behalf of Lake County, an agreement, and any amendments, between Wold Architects and Engineers in the amount of \$57,590 for design of digital wayfinding standards for the Waukegan Campus.
