Resolution authorizing a contract with Simon Roofing, Macedonia, Ohio, for the roof replacement of the Center Courts building in the amount of \$1,120,964.

- As part of Fiscal Year 2020 budget process, funding was appropriated to replace the roof of the Center Courts building.
- The existing roof is beyond its useful life and needs replacement. The new roof will be a fourply system with a 20-year warranty and will improve the thermal efficiency of the building envelope.
- Lake County Purchasing identified a cooperative purchasing contract with Simon Roofing through the TIPS-USA Contract to procure the needed service.
- Pursuant to Article 10-101 of the Lake County Purchasing Ordinance, Cooperative Purchasing, Lake County may participate in a cooperative purchasing agreement for the procurement of goods with one or more public procurement units in accordance with an agreement entered into between the participants.
