WHEREAS, Lake County IT/Enterprise Technology identified a cooperative purchasing contract with CDW through National Intergovernmental Purchasing Alliance (NIPA) to procure the needed goods, services or professional services that was competitively solicited and awarded.

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Purchasing Agent is authorized to enter into a one-year contract with CDW for Cisco Smartnet software maintenance in the total amount of \$68,726.82, charged to account number 101-1300010-71230.
