Joint resolution accepting the Illinois Department of Commerce and Economic Opportunity (DCEO) Workforce Innovation and Opportunity Act (WIOA) Statewide Activities grant and approving an emergency appropriation in the amount of \$166,005.

- The WIOA Statewide Activities Grant is a technical assistance grant to develop and implement regional activities and training.
- DCEO has approved a grant budget for regional planning and system integration in the Northeast Economic Development Region along with expansion of the regional integrated business service team and Job Center partner and one-stop operator training and development.
- The grant activities will be led by a regional coordinator and is for the period of June 1, 2020 through June 30, 2021.

RESOLUTION

WHEREAS, The Illinois Department of Commerce and Economic Opportunity has provided WIOA Statewide Activities Grant totaling \$166,005 to the Lake County Workforce Development Department; and,

WHEREAS this funding covers travel and training expenses for regional planning in the northeast Economic Development Region; and

WHEREAS, this grant is for the program period of June 1, 2020 through June 30, 2021;
