Joint resolution appropriating \$29,100 (\$9,700 annually) of Matching Tax funds for three years of maintenance service for the Lake County Division of Transportation Sign Inventory System.

- The Lake County Division of Transportation (LCDOT) maintains over 27,400 signs and uses an electronic and mobile inventory system.
- LCDOT purchased a new Sign Inventory System from 3M Company, St. Paul, Minnesota, in 2016.
- The agreement with 3M Company provides for annual maintenance.
- Annual maintenance service for the years 2021 to 2023 will be invoiced separately.
- This maintenance cost is included in the highway improvement program, and designated as Section 21-00000-20-GM.

RESOLUTION

WHEREAS, the Lake County Division of Transportation maintains over 27,400 signs along various county highways and nonmotorized paths; and

WHEREAS, the Lake County Division of Transportation purchased a new Sign Inventory System from 3M Company, St. Paul, Minnesota, in 2016; and

WHEREAS, the agreement with 3M Company provides for annual maintenance; and

WHEREAS, three years of annual maintenance service for the sign inventory system software will be provided in the years 2021 through 2023; and

WHEREAS, an appropriation of funds is needed.

NOW, THEREFORE BE IT RESOLVED by this Lake County Board, that there is hereby appropriated \$29,100 of Matching Tax funds for three years of maintenance service (\$9,700 annually) with 3M Company, for the Lake County Division of Transportation Sign Inventory System, a draft copy of the original agreement and the purchase order are attached hereto, and designated as Section 21-00000-20-GM.
