Joint resolution accepting the Delta Dental of Illinois Foundation grant and authorizing an emergency appropriation in the amount of \$50,000 for the Coronavirus (COVID-19) grant.

- The \$50,000 Delta Dental of Illinois Foundation grant will be used to purchase high-volume equipment, portable High Efficiency Particulate Air (HEPA) filters, dental and Personal Protective Equipment (PPE) supplies.
- The \$50,000 in additional grant funding has not been previously appropriated because the grant resources were secured after the County’s adoption of the Fiscal Year (FY) 2020 budget.
- The grant award will be for the period June 24, 2020 through December 31, 2020.

### RESOLUTION

**WHEREAS**, the Lake County Health Department and Community Health Center has received a grant increase delivered by our Clinical Operations Unit; and

**WHEREAS**, these dollars will provide a legitimate increase in services to Lake County with no impact on local taxes; and

**WHEREAS**, this grant amount totaling \$50,000 has not been previously appropriated, having been awarded after adoption of the Fiscal Year 2020 budget; and

**WHEREAS**, the proposed appropriation will be fully offset by the above referenced items thereby not requiring the expenditure of local tax revenue.

**NOW, THEREFORE, BE IT RESOLVED**, by this County Board of Lake County, Illinois, that

an emergency appropriation in the amount of \$50,000 is hereby authorized in the Health Department budget as identified on the listing of expense and revenue budget modifications attached hereto and made part hereof; and

**BE IT FURTHER RESOLVED**, that the revenue budgets as identified on the attached listing be modified as provided by increased funding from the following:

Delta Dental of Illinois Foundation - COVID-19, \$50,000.
