Joint resolution accepting the Illinois Capital Development Board grant and authorizing an emergency appropriation in the amount of \$3,000,000 for the Community Health Center Construction Act grant.

- The \$3,000,000 Illinois Capital Development Board grant will be used to complete improvements to the health centers in Zion, North Chicago, and the Belvidere Medical Building.
- The \$3,000,000 in additional funding has not been previously appropriated because the resources were secured after the County's adoption of the Fiscal Year (FY) 2020 budget.
- The funding will be for the period August 1, 2020 through July 31, 2022.

### RESOLUTION

**WHEREAS**, the Lake County Health Department and Community Health Center has received a funding increase delivered by our Administration Unit; and

**WHEREAS**, these dollars will provide a legitimate increase in services to Lake County with no impact on local taxes; and

**WHEREAS**, this funding amount totaling \$3,000,000 has not been previously appropriated, having been awarded after adoption of the FY 2020 budget; and

**WHEREAS**, the proposed appropriation will be fully offset by the above referenced items thereby not requiring the expenditure of local tax revenue.

**NOW, THEREFORE, BE IT RESOLVED**, by this County Board of Lake County, Illinois, that an emergency appropriation in the amount of \$3,000,000 is hereby authorized in the Health Department budget as identified on the listing of expense and revenue budget modifications attached hereto and made part hereof; and

**BE IT FURTHER RESOLVED**, that the revenue budgets as identified on the attached listing be modified as provided by increased funding from the following:

Illinois Capital Development Board - Community Health Center Construction Act, \$3,000,000.
