Joint resolution accepting the United States Department of Health and Human Services reimbursement and authorizing an emergency appropriation in the amount of \$255,413.21 for the Coronavirus Aid, Relief and Economic Security (CARES) Act Provider Relief Fund.

- The \$255,413.21 United States Department of Health and Human Services reimbursement will be used to support healthcare-related expenses.
- The \$255,413.21 in additional funding has not been previously appropriated because the resources were secured after the County's adoption of the Fiscal Year (FY) 2020 budget.
- The reimbursement will be for the period April 1, 2020 through July 31, 2021.

## RESOLUTION

**WHEREAS**, the Lake County Health Department and Community Health Center has received a funding increase delivered by our Clinical Operations Unit; and

**WHEREAS**, these dollars will provide a legitimate increase in services to Lake County with no impact on local taxes; and

**WHEREAS**, this funding amount totaling \$255,413.21 has not been previously appropriated, having been awarded after adoption of the FY 2020 budget; and

**WHEREAS**, the proposed appropriation will be fully offset by the above referenced items thereby not requiring the expenditure of local tax revenue.

**NOW, THEREFORE, BE IT RESOLVED**, by this County Board of Lake County, Illinois, that an emergency appropriation in the amount of \$255,413.21 is hereby authorized in the Health Department budget as identified on the listing of expense and revenue budget modifications attached hereto and made part hereof; and

**BE IT FURTHER RESOLVED**, that the revenue budgets as identified on the attached listing be modified as provided by increased funding from the following:

U.S. Department of Health & Human Services - CARES Act Provider Relief Fund, \$255,413.21.
