Joint resolution accepting the Illinois Department of Commerce and Economic Opportunity (DCEO) Trade Adjustment Assistance (TAA) grant; and approving an emergency appropriation in the amount of \$2,200.

- The TAA federal program provides funding for reemployment services to displaced workers who have lost their jobs as a result of increased imports or shifts in production outside the United States.
- The funds of \$2,200 will be used for expenses associated with payment processing.
- The grant period is January 1, 2020 through September 30, 2020.

## RESOLUTION

**WHEREAS**, The Illinois Department of Commerce and Economic Opportunity has provided Trade Adjustment Assistance (TAA) grants totaling \$2,200 to the Lake County Workforce Development Department; and,

**WHEREAS**, this TAA grant is for the program period of January 1, 2020 through September 30, 2020; and

**WHEREAS** this grant covers training and transportation expenses for displaced workers and

payment processing; and

**WHEREAS**, an emergency appropriation of \$2,200 is requested to allocate these funds into the Workforce Department's county fiscal year 2020 budget and authorize acceptance of this grant.

**NOW, THEREFORE, BE IT RESOLVED**, by this County Board of Lake County, Illinois, that an emergency appropriation in the amount of \$2,200 for the Workforce Development Department is hereby approved and that the TAA grants be accepted.
