Resolution approving a Collective Bargaining Agreement (CBA) between the Lake County Division of Transportation (LCDOT) and the International Union of Operating Engineers, Local 150, Public Employees Division.

- This is a two-year agreement beginning April 1, 2021 through March 31, 2023 and covers approximately 70 employees in the LCDOT.

RESOLUTION

WHEREAS, the Operating Engineers Local Number 150 has been recognized as the sole and exclusive bargaining agent for certain employees in the Lake County Division of Transportation; and

WHEREAS, a successor collective bargaining agreement has been negotiated with the Operating Engineers Local 150, as the exclusive representative of certain employees in the Lake County Division of Transportation, consistent with the Illinois Public Labor Relations Act; and

WHEREAS, the Financial and Administrative Committee reviewed and approved said agreement at its January 7, 2020 meeting.

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, that the Chair of the County Board is hereby authorized to sign the Collective Bargaining Agreement attached hereto and made a part of this resolution; and

BE IT FURTHER RESOLVED, that this Agreement shall be effective from April 1, 2021 through March 31, 2023, consistent with the Illinois Public Labor Relations Act 5 ILCS 315/21.
