Resolution authorizing a Collective Bargaining Agreement (CBA) between the Lake County Board, Lake County Sheriff's Office, and the Correctional Division Teamsters Local 700.

- This is a four-year agreement retroactive to December 1, 2016 through November 30, 2020 and covers approximately 177 employees in the Corrections Division of the Sheriff's Department.

## RESOLUTION

**WHEREAS**, the Teamsters Local 700, has been recognized as the sole and exclusive bargaining agent for certain employees in the Lake County Facilities Operations Division, and

**WHEREAS**, negotiations between the County Board, Sheriff and the Teamsters on a successor collective bargaining agreement went on for almost four years; and

**WHEREAS**, the parties were at impasse and an Arbitration Panel was selected to resolve the outstanding issues; and

**WHEREAS**, the Arbitration Panel delivered their decision on the open issues and the parties are bound by their decision; and

**WHEREAS**, the parties have updated the collective bargaining agreement to reflect; and

**NOW, THEREFORE, BE IT RESOLVED**, by this the County Board of Lake County, that the Madam Chair of the Board is hereby authorized to sign the Collective Bargaining Agreement attached hereto and make a part of this Resolution.

**BE IT FURTHER RESOLVED**, that this Agreement shall be effective from December 1, 2016 through November 30, 2020 consistent with the Illinois Public Labor Relations Act 5ILCS 315/21.
