## RESOLUTION

**WHEREAS,** the Lake County Health Department and Community Health Center has received a grant increase delivered by our Prevention Unit; and

**WHEREAS,** these dollars will provide a legitimate increase in services to Lake County with no impact on local taxes; and

**WHEREAS,** this grant amount totaling \$80,535.50 has not been previously appropriated, having been awarded after adoption of the Fiscal Year 2021 budget; and

**WHEREAS**, the proposed appropriation will be fully offset by the above referenced items thereby not requiring the expenditure of local tax revenue.

**NOW, THEREFORE, BE IT RESOLVED,** by this County Board of Lake County, Illinois, that an emergency appropriation in the amount of \$80,535.50 is hereby authorized in the Health Department budget as identified on the listing of expense and revenue budget modifications attached hereto and made part hereof; and

**BE IT FURTHER RESOLVED**, that the revenue budgets as identified on the attached listing be modified as provided by increased funding from the following:

Des Plaines River Watershed Workgroup Lakes Project - Water Quality Monitoring, \$80,535.50.
