Joint resolution authorizing separate agreements with the City of Park City and the City of Waukegan for the proposed widening and resurfacing of Illinois Route 120, from Knight Avenue to Illinois Route 131.

- The City of Park City desires the County to install sidewalk as part of the improvement. The City of Park City also owns watermain within the project limits that requires modification.
- The City of Park City will reimburse Lake County for the engineering and construction costs associated with this work, estimated to be \$30,941.
- The City of Waukegan desires the County to install sidewalk as part of the improvement. The City of Waukegan also owns street lighting that will require modification.
- The City of Waukegan will reimburse the County for the engineering and construction costs associated with this work, estimated to be \$61,952.
- Each agreement has been approved by the respective municipality and the project is included in the Transportation Improvement Program, and designated as Section 12-00999-31-WR.

## RESOLUTION

**WHEREAS**, to ensure the free flow of traffic and safety for the welfare of the traveling public, Lake County, the City of Park City, and the City of Waukegan are desirous of improving Illinois Route 120, from Knight Avenue to Illinois Route 131, by widening and resurfacing, inclusive of non-motorized improvements; and **WHEREAS,** the City of Park City owns watermain within the project limits that requires modification; and

**WHEREAS,** the City of Waukegan owns street lighting within the project limits that requires modification and a red-light camera system within the project limits that will be removed; and

**WHEREAS,** the City of Park City and the City of Waukegan desire that the County include non-motorized improvements as part of the improvement; and

**WHEREAS,** the City of Park City and the City of Waukegan will reimburse the County for their respective share of these improvements; and

**WHEREAS,** the City of Park City and the City of Waukegan are desirous of entering into separate agreements with Lake County stating the terms and conditions for their respective improvements, draft copies of which are attached hereto.

**NOW, THEREFORE BE IT RESOLVED** by this Lake County Board, that the County Board Chair, the County Clerk, and the County Engineer of Lake County are authorized, and are hereby directed to enter into an agreement, and any amendments, between Lake County and the City of Park City stating the terms and conditions for water main modification and installation of non-motorized facilities along Illinois Route 120, from Knight Avenue to Illinois Route 131, and designated as Section 12-00999-31-WR.

**BE IT FURTHER RESOLVED** that the County Board Chair, the County Clerk, and the County Engineer of Lake County are authorized, and are hereby directed to enter into an agreement, and any amendments, between Lake County and the City of Waukegan stating the terms and conditions for street lighting modification, red-light camera system removal, and installation of non-motorized facilities along Illinois Route 120, from Knight Avenue to Illinois Route 131, and designated as Section 12-00999-31-WR.

**BE IT FURTHER RESOLVED** that the County Engineer shall transmit, in writing, the final agreements and any amendments, to be executed by the County Board Chair and the County Clerk.
