Joint resolution authorizing a contract with SKC Construction, Inc., Elgin, Illinois, in the amount of \$42,753.55 to provide for the crack sealing of hot-mix asphalt and concrete pavements, where necessary, on various County highways under the Illinois Highway Code, appropriating \$55,000 of Motor Fuel Tax funds.

- Lake County's Crack Sealing Program is an annual preventative maintenance program
 consisting of applying crack sealing at various locations to prevent the intrusion of water and
 incompressible material into the cracks and to reinforce the adjacent pavement.
- There was a public call for bids, and a total of two bids were received, ranging from \$42,753.55 to \$64,384.55, and the lowest responsible bidder is SKC Construction, Inc., Elgin, Illinois, in the amount of \$42,753.55.
- This project is included in the Transportation Improvement Program with construction in 2021, and designated as Section 21-00000-04-GM.

RESOLUTION

WHEREAS, pursuant to authority granted by this Lake County Board, the County Engineer heretofore called for sealed bids, by publication, to provide crack sealing of hot-mix asphalt and concrete pavement, where necessary, on various County highways, and designated as Section 21-00000-04-GM; and

WHEREAS, pursuant to said publication and calling for said bids, sealed bids were received

and opened on March 16, 2021, at 10:00 a.m. at the Lake County Division of Transportation in Libertyville, Illinois; a tabulation of said bids being as follows:

SKC Construction, Inc. Elgin, Illinois \$42,753.55

Denler, Inc. Joliet, Illinois \$64,384.55

WHEREAS, the Public Works, Planning and Transportation Committee, the County Engineer, and the Purchasing Agent have examined each bid, and it appears that the lowest responsible bidder is SKC Construction, Inc., Elgin, Illinois, in the amount of \$42,753.55, based on estimated quantities and unit prices; and

WHEREAS, an appropriation of funds is required.

NOW, THEREFORE BE IT RESOLVED by this Lake County Board, that a contract be awarded to said SKC Construction, Inc., Elgin, Illinois, in the amount of \$42,753.55, based on estimated quantities and unit prices, and that the Purchasing Agent, the County Clerk, and the County Engineer of Lake County be authorized and they are hereby directed to enter into a contract with said low bidder to provide crack sealing of hot-mix asphalt and concrete pavements, where necessary, on various County highways, and designated as Section 21-00000-04-GM.

BE IT FURTHER RESOLVED that in as much as such estimated quantities are the best approximation that can be determined at this time, these quantities may be added to, deducted from, or modified from in the final determination of the contract cost in accordance with Chapter 605 of the Illinois Compiled Statutes, Act 5, Section 5-205.2 without further Board action, providing the final cost chargeable to the funds appropriated does not exceed the appropriation.

BE IT FURTHER RESOLVED that the County Clerk is hereby directed to transmit four certified originals of this resolution to the district office of the Department of Transportation.

BE IT FURTHER RESOLVED that this award be processed by the County Engineer for final approval of the Illinois Department of Transportation in accordance with the "Agreement of Understanding" between the Illinois Department of Transportation and Lake County, dated May 3, 2018.

BE IT FURTHER RESOLVED that there is hereby appropriated \$55,000 of Motor Fuel Tax funds.
