Joint resolution accepting the Illinois Department of Human Services (IDHS) grant and authorizing an emergency appropriation in the amount of \$5,820 for the Mental Health Community Integrated Living Arrangement grant.

- The \$5,820 IDHS grant will be used to offset existing salary and fringe benefits.
- The \$5,820 in additional grant funding has not been previously appropriated because the grant resources were secured after the County's adoption of the Fiscal Year (FY) 2021 budget.
- The grant award will be for the period July 1, 2020 through June 30, 2021.

## RESOLUTION

**WHEREAS,** the Lake County Health Department and Community Health Center has received a grant increase delivered by our Clinical Operations Unit; and

**WHEREAS,** these dollars will provide a legitimate increase in services to Lake County with no impact on local taxes; and

**WHEREAS,** this grant amount totaling \$5,820 has not been previously appropriated, having been awarded after adoption of the FY 2021 budget; and

**WHEREAS,** the proposed appropriation will be fully offset by the above referenced items thereby not requiring the expenditure of local tax revenue.

**NOW, THEREFORE, BE IT RESOLVED,** by this County Board of Lake County, Illinois, that an emergency appropriation in the amount of \$5,820 is hereby authorized in the Health Department budget as identified on the listing of expense and revenue budget modifications attached hereto and made part hereof; and

**BE IT FURTHER RESOLVED**, that the revenue budgets as identified on the attached listing be modified as provided by increased funding from the following:

Illinois Department of Human Services - Mental Health Community Integrated Living Arrangement, \$5,820.
