Joint resolution authorizing a contract with Lake County Grading Company, Libertyville, Illinois, in the amount of \$318,536.25 for the replacement of various culverts on Gilmer Road, Monaville Road, and Old McHenry Road and appropriating \$385,000 of County Bridge Tax funds.

- Three culverts located on Gilmer Road, Monaville Road, and Old McHenry Road are at the end of their life cycle and must be replaced.
- There was a public call for bids, and a total of five bids were received, ranging from \$318,536.25 to \$425,676, and the lowest responsible bidder is Lake County Grading Company, in the amount of \$318,536.25.
- This project is included in the Transportation Improvement Program with construction planned in 2021, and designated as Section 18-00999-58-DR.

RESOLUTION

WHEREAS, pursuant to authority granted by this Lake County Board, the County Engineer heretofore called for sealed bids, by publication, for the culvert replacements on Gilmer Road, Monaville Road, and Old McHenry Road; and

WHEREAS, pursuant to said publication and calling for said bids, sealed bids were received and opened on June 15, 2021, at 10:00 a.m. at the Lake County Division of Transportation in Libertyville, Illinois; a tabulation of said bids being as follows:

WHEREAS, the Public Works, Planning and Transportation Committee, the County Engineer and the Purchasing Agent have examined each bid, and the lowest responsible bidder is Lake County Grading Company, their bid being \$318,536.25 based on estimated quantities and unit prices; and

WHEREAS, an appropriation of funds is required.

NOW, THEREFORE BE IT RESOLVED by this Lake County Board, that a contract be awarded to said Lake County Grading Company, in accordance with their bid of \$318,536.25, based on estimated quantities and unit prices, and that the Purchasing Agent, the County Clerk, and the County Engineer of Lake County be authorized and they are hereby directed to enter into a contract with said low bidder for the culvert replacements on Gilmer Road, Monaville Road, and Old McHenry Road, and designated as Section 18-00999-58-DR.

BE IT FURTHER RESOLVED that in as much as such estimated quantities are the best approximation that can be determined at this time, these quantities may be added to, deducted from, or modified from in the final determination of the contract cost in accordance with Chapter 605 of the Illinois Compiled Statutes, Act 5, Section 5-205.2 without further Board action, providing the final cost chargeable to the funds appropriated does not exceed the appropriation.

BE IT FURTHER RESOLVED that there is hereby appropriated \$385,000 of County Bridge Tax funds.
