Joint resolution authorizing an emergency appropriation with offsetting revenue in the amount of \$20,000 to support the Nineteenth Judicial Circuit Court's Self-Represented Litigant Coordinator.

- The Illinois Supreme Court Commission on access to Justice has awarded the Nineteenth Judicial Circuit Court \$20,000 to support the work of the Court's Self-Represented Litigants (SRL) Coordinator.
- Allowable uses for these funds are for partial funding of the Self-Represented Litigant Coordinators salary, continuation of an early resolution program, web-site development to include chat feature and supplies and equipment.
- The Court has received grant funding under this program since FY 2018
- This resolution authorizes an emergency appropriation of \$20,000. This grant does not require a match.

## RESOLUTION

**WHEREAS**, the Illinois Supreme Court Commission on Access to Justice has awarded the Nineteenth Judicial Circuit Court \$20,000 to support the work of the Court's SRL Coordinator for the grant period of August 1, 2021 through July 31, 2022; and

**WHEREAS**, the funding will be used to partially offset the salary of the Self-Represented Litigant Coordinator, continue the Nineteenth Judicial Circuit Court's early resolution program and aid in the development of a chat feature on the Court's web-site; and

**WHEREAS**, the funding will be used to partially offset the salary of the Self-Represented Litigant Coordinator, continue the Nineteenth Judicial Circuit Court's early resolution program and aid in the development of a chat feature on the Court's web-site; and

**WHEREAS**, the County Board must authorize an emergency appropriation of \$20,000 to implement this grant.

**NOW, THEREFORE, BE IT RESOLVED**, by this County Board of Lake County, Illinois, that the County Board authorizes an emergency appropriation with offsetting revenue in the amount of \$20,000, to support the work of the Nineteenth Judicial Circuit Court's Self-Represented Litigant (SRL) Coordinator for the grant period of August 1, 2021 through July 31, 2022.
