Resolution authorizing a license agreement with Vizzion Enterprises, Inc., for use of closed-circuit television (CCTV) camera snapshot images of real-time traffic conditions in the County made publicly available through Lake County PASSAGE.

- The license agreement sets terms and conditions for the licensing of real-time snapshot images of traffic conditions.
- The agreement sets conditions for incorporating images from the PASSAGE monitoring cameras into Vizzion's platform.
- Vizzion aggregates images from several public sources and makes them more readily available for third party use.
- The agreement can be terminated by either party with 30 days' advance notice.

RESOLUTION

WHEREAS, the Lake County Division of Transportation (LCDOT) has undertaken the development and implementation of an Advanced Traffic Management System (ATMS) in order to improve the efficiency of motor vehicle traffic throughout Lake County, and Lake County PASSAGE is the County's ATMS, employing a fiber optic network interconnecting traffic signals, cameras and network equipment along County highways, state roads, and toll roads to collect traffic signal data and images which are sent to LCDOT's Transportation Management Center (TMC) by way of this network; and

WHEREAS, Vizzion Enterprises, Inc., has expressed a desire to provide LCDOT's closed-circuit television (CCTV) camera snapshot images of real-time traffic conditions in the County

on Vizzion's platform; and

WHEREAS, LCDOT desires to enter into an agreement with Vizzion Enterprises, Inc., to establish terms and conditions for the licensing of real-time snapshot images of traffic conditions in the County.

NOW, THEREFORE BE IT RESOLVED by this Lake County Board, that the County Board Chair, the County Clerk, and the County Engineer of Lake County, Illinois, are authorized, and are hereby directed to enter into a license agreement, and any amendments, between Lake County and Vizzion Enterprises, Inc., for use of CCTV camera snapshot images of real-time traffic conditions in the County.

BE IT FURTHER RESOLVED that the County Engineer shall transmit, in writing, the final agreement, and any amendments, to be executed by the County Board Chair and the County Clerk.
