Joint resolution accepting the Health Resources and Services Administration grant and authorizing an emergency appropriation in the amount of \$927,053 for the Health Center Construction and Capital Improvements grant.

- The \$927,053 Health Resources and Services Administration grant will fund alterations and renovations at Belvidere Medical Building, Midlakes Health Center, Zion Health Center, and North Chicago Health Center.
- The \$927,053 in additional grant funding has not been previously appropriated because the grant resources were secured after the County's adoption of the Fiscal Year (FY) 2022 budget.
- The grant award will be for the period September 1, 2021 through August 31, 2024.

RESOLUTION

WHEREAS, the Lake County Health Department and Community Health Center has received a grant increase delivered by our Clinical Operations Unit; and

WHEREAS, these dollars will provide a legitimate increase in services to Lake County with no impact on local taxes; and

WHEREAS, this grant amount totaling \$927,053 has not been previously appropriated, having been awarded after adoption of the FY 2022 budget; and

WHEREAS, the proposed appropriation will be fully offset by the above referenced items

thereby not requiring the expenditure of local tax revenue.

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that an emergency appropriation in the amount of \$927,053 is hereby authorized in the Health Department budget as identified on the listing of expense and revenue budget modifications attached hereto and made part hereof; and

BE IT FURTHER RESOLVED, that the revenue budgets as identified on the attached listing be modified as provided by increased funding from the following:

Health Resources and Services Administration - Health Center Construction and Capital Improvements, \$927,053.
