Joint resolution accepting the Schreiber Foundation grant and authorizing an emergency appropriation in the amount of \$5,000 for the iGrow grant.

- The \$5,000 Schreiber Foundation grant will used to support existing staff.
- The \$5,000 in additional grant funding has not been previously appropriated because the grant resources were secured after the County’s adoption of the Fiscal Year (FY) 2022 budget.
- The grant award will be for the period December 1, 2021, through November 30, 2022.

### RESOLUTION

**WHEREAS**, the Lake County Health Department and Community Health Center has received a grant increase delivered by our Administration Unit; and

**WHEREAS**, these dollars will provide a legitimate increase in services to Lake County with no impact on local taxes; and

**WHEREAS**, this grant will be used for a new position that will be eliminated if or when this grant’s funding is no longer available and no other funding source outside of property tax dollars has been identified; and

**WHEREAS**, this grant amount totaling \$5,000 has not been previously appropriated, having been awarded after adoption of the Fiscal Year 2022 budget; and

**WHEREAS**, the proposed appropriation will be fully offset by the above referenced items

thereby not requiring the expenditure of local tax revenue.

**NOW, THEREFORE, BE IT RESOLVED**, by this County Board of Lake County, Illinois, that an emergency appropriation in the amount of \$5,000 is hereby authorized in the Health Department budget as identified on the listing of expense and revenue budget modifications attached hereto and made part hereof; and

**BE IT FURTHER RESOLVED**, that the revenue budgets as identified on the attached listing be modified as provided by increased funding from the following:

Schreiber Foundation - iGrow, \$5,000.
