- The 19th Judicial Circuit Court was awarded grant funding from the Supreme Court of Illinois
 Court Technology Modernization Program to provide services benefiting the court, court users
 and justice partners.
- Case Center from Thomson Reuters (DBA West Publishing Corporation) was identified as new technology to streamline hearings and trials for courts, expedite case resolution for prosecutors and defense counsel, and improve case preparation for self-represented litigants.
- Lake County has an existing contract with West Publishing Corporation for online Legal, Public Record, Investigative, and Research, which was approved by the County Board on July 13, 2021, in the amount of \$222,613.20. Contract Modification One was approved on November 2, 2021, to include the cost for legal publications for the law library in the amount of \$115,512 under the existing contract.
