Joint Resolution authorizing execution of a contract with G.P. Maintenance Services, Inc. of Palos Hills, Illinois, in the amount of \$426,000 for the Fiscal Year 2022 Painting Projects for Lake County Public Works.

- There is a need to perform painting projects at the following Public Works locations: New Century Town Wastewater Treatment Plant, Mill Creek Wastewater Treatment Plant, Rollins Road Pump Station, Brooks Farm Well House, Petite Lake Pump Station, Grainger, and Greggs Reservoir.
- The County received bids from two (2) contractors for this work ranging from \$426,000 to \$896,000.
- Award of this contract is recommended to the lowest responsive and responsible bidder, G.P. Maintenance Services, Inc. of Palos Hills, Illinois, who best meets the needs of the County in the amount of \$426,000.
- This resolution authorizes and directs the County Purchasing Agent to execute a contract with G.P. Maintenance Services, Inc. of Palos Hills, Illinois, in the amount of \$426,000.

RESOLUTION

WHEREAS, the County of Lake (County) owns, operates, and maintains wastewater treatment plants, pump stations, and well houses and reservoirs as part of the water system;

WHEREAS, there is a need to perform annual maintenance at various Public Works locations; and

WHEREAS, the painting projects will be completed at the following locations: New Century Town Wastewater Treatment Plant, Mill Creek Wastewater Treatment Plant, Rollins Road Pump Station, Brooks Farm Well House, Petite Lake Pump Station, Grainger and Greggs Reservoir; and

WHEREAS, in accordance with the Lake County Purchasing Ordinance, bids were called for by publication for the Fiscal Year 2022 Painting Projects for Lake County Public Works; and

WHEREAS, G.P. Maintenance Services, Inc. is the lowest responsive, responsible bidder in the amount of \$426,000; the other bid received in the amount of \$896,000.

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Purchasing Agent is hereby authorized and directed to execute a contract with G.P. Maintenance Services, Inc. of Palos Hills, Illinois in the amount of \$426,000 for the Fiscal Year 2022 Painting Projects for Lake County Public Works.
