- The Division of Transportation (DOT) has utilized Trimble equipment for many years and has found such equipment meets our needs.
- Pursuant to Chapter 33.066 Bid Exemption of the Lake County Purchasing Ordinance, the Purchasing Agent has made a determination based on previous bid exemptions (2014 and 2020) that there is only one single source approved as an authorized dealer for the region.
- Seiler Instrument and Manufacturing Company, Inc. is the only authorized dealer in the Midwest for Trimble equipment.
- This agreement includes the purchase of one Trimble GPS unit along with the related equipment and accessories.
- The appropriation also covers cellular service and Trimble VRSNow service required to operate the equipment.
- This equipment is used for Phase III engineering services and is included in the Transportation Improvement Program, and designated as Section 22-00800-00-EQ.

RESOLUTION

WHEREAS, the Division of Transportation (DOT) has utilized Trimble equipment for many

years and has found such equipment meets our needs; and

WHEREAS, Pursuant to Chapter 33.066 Bid Exemption of the Lake County Purchasing Ordinance, the Purchasing Agent has made a determination based on previous bid exemptions (2014 and 2020) that there is only one single source approved as an authorized dealer for the region; and

WHEREAS, Seiler Instrument and Manufacturing Company, Inc., Itasca, Illinois, is the only authorized dealer in the Midwest for Trimble equipment; and

WHEREAS, this agreement includes the purchase of one Trimble Global Positioning System (GPS) unit along with the related equipment and accessories; and

WHEREAS, monthly cellular service and annual Trimble VRSNow service used to operate the equipment will also be purchased from this appropriation; and

WHEREAS, an appropriation of funds is required.

NOW, THEREFORE BE IT RESOLVED by this Lake County Board, that the Purchasing Agent is hereby authorized and directed to enter into an agreement with Seiler Instrument and Manufacturing Company, Inc., Itasca, Illinois, for the purchase of one Trimble GPS Unit and related equipment and accessories for the Lake County Division of Transportation.

BE IT FURTHER RESOLVED that there is hereby appropriated \$60,000 of ¼% Sales Tax for Transportation funds, and designated as Section 22-00800-00-EQ.
