Joint resolution authorizing a contract with Water Well Solutions Illinois Division, LLC of Elburn, Illinois in the amount of \$63,450 annually for well pump maintenance and repair services.

- The County owns active and standby well water systems that require on-going maintenance and repair.
- The current contract expired on August 18, 2022.
- The County received bids from two contractors for this work, ranging from \$63,450 to \$228,300. Water Well Solutions Illinois LLC., was determined to be the lowest responsive and responsible bidder who best meets the needs of the County in an estimated amount of \$63,450 annually. The contract has a two-year term period with the opportunity to extend for three one-year periods.
- This resolution authorizes and directs the County Purchasing Agent to execute a contract with Water Well Solutions Illinois Division, LLC, Elburn, IL in the amount of \$63,450.00 annually for well pump maintenance and repair services.

### RESOLUTION

**WHEREAS**, the County of Lake (County) owns and operates well water systems throughout the County in areas such as: Countryside Lake, Brooks Farm, Pekara, and Highland Lake; and

**WHEREAS**, the well pumps and casings in the water systems are in need of inspection, maintenance, and repair on an on-going basis; and

**WHEREAS**, in accordance with the Lake County Purchasing Ordinance, bids were called for by publication for Well Pump Maintenance and Repair Services; and

**WHEREAS**, two sealed bids were received, Water Well Solutions Illinois Division, LLC is the lowest responsive and responsible bidder in the amount of \$63,450 annually.

**NOW, THEREFORE, BE IT RESOLVED**, by this County Board of Lake County, Illinois, that the Purchasing Agent is hereby authorized and directed to execute a two-year contract with Water Well Solutions Illinois Division, LLC Division, Elburn, IL in the amount of \$63,450 annually for Well Pump Maintenance and Repair Services.
