# Provider Relations

- Our Zion location will be offering dental hygiene services beginning in September. We plan to staff the site with a dental hygienist two days per week.
- We recently hired a new dental assistant for our Midlakes location and their start date was August 29, 2022.
- Our Grand Avenue location will add a second dental assistant in mid-September. This position was filled by an internal candidate.
- We anticipate our North Chicago office to return to full time operations on October 3, 2022, as the fulltime provider who covers that site will be returning from FMLA.
- Dental currently has no open provider positions.

# Operations

- A six-month dental grant report was sent to The Delta Dental Foundation.
- The most recent data for the dental grant was an August outreach that includes 135 pediatric outreach calls and 12 pediatric appointments.
