Joint Resolution adopting the Proposed 2023-2027 Capital Improvement Program for the Lake County Department of Public Works.

- The five-year Capital Improvement Program is a planning document that serves as a guide for Lake County Department of Public Works future capital improvements.
- The Interim Director of Public Works and Department of Public Works staff have prepared the Proposed 2023-2027 Capital Improvement Program.
- The Department of Public Works staff presented the Proposed 2023-2027 Capital Improvement Program to the Public Works, Planning and Transportation Committee on September 7, 2022.
- The Proposed 2023-2027 Capital Improvement Program aligns with the County Board Strategic Plan adopted in July 2019 and incorporates the following Strategic Goals: Improve Infrastructure and Promote a Sustainable Environment.

RESOLUTION

WHEREAS, in order to provide for a comprehensive and coordinated system of water and wastewater capital improvements, it is necessary to undertake a multi-year approach to the planning of said improvements; and

WHEREAS, the Lake County Department of Public Works annually prepares an updated five-year Capital Improvement Program; and

WHEREAS, said Capital Improvement Program is a planning document and is therefore intended as a guide for future improvements and is subject to modification; and

WHEREAS, Department of Public Works staff presented the Proposed 2023-2027 Capital Improvement Program to the Public Works, Planning and Transportation Committee on September 7, 2022; and

WHEREAS, the Proposed 2023-2027 Capital Improvement Program aligns with the County Board Strategic Plan adopted in July 2019, and includes the following Strategic Goals: Improve Infrastructure and Promote a Sustainable Environment.

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that the County Board hereby adopts the 2023-2027 Capital Improvement Program as the official capital program for the Department of Public Works.

BE IT FURTHER RESOLVED, that the Interim Director of Public Works shall cause to be published a final draft of the 2023-2027 Capital Improvement Program and for making available to the public on the Department of Public Works website and other appropriate mediums.
