Joint resolution approving an intergovernmental agreement (IGA) for contractual police services by and among the Village of Beach Park (Beach Park), Lake County and the Lake County Sheriff's Office (LCSO) from January 1, 2023, to December 31, 2025 in the amount of \$2,148,047.04.

- Beach Park and LCSO has agreed to renew the police services contract for a three-year period from January 1, 2023, through December 31, 2025.
- LCSO has provided police services to Beach Park for 21 years
- The contract includes a continuation of the current services which include two 8.5-hour shifts per day, from 6:30 a.m. to 11:00 p.m.
- The State's Attorney's Office has reviewed this renewal contract.
- Beach Park will reimburse the cost of the two (2) contract deputy positions for all three years.

RESOLUTION

WHEREAS, the Village of Beach Park has requested that the Sheriff continue to provide police services to the said Village; and

WHEREAS, the Village of Beach Park has requested the continuation of police services for two eight and one-half hour shifts per day; and

WHEREAS, the Sheriff has negotiated an Intergovernmental Agreement with the Village relative to providing said services.

WHEREAS, the County and the Village are proposing that the new rate for policing services will be:

Effective Date	Monthly Cost	Annual Cost
January 1, 2023	\$58,557.15	\$702,685.83
January 1, 2024	\$59,762.71	\$717,152.47
January 1, 2025	\$60,684.06	\$728,208.74

The monthly installment is due on the fifteenth day of each month, beginning in January; and

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Chair of the Board and the Sheriff are hereby authorized to execute an Intergovernmental Agreement with the Village of Beach Park for the purpose of continuing to provide police services in the Village, effective January 1, 2023.
