Joint resolution authorizing a contract with Rausch Infrastructure, LLC, Des Plaines, Illinois, in the amount of \$1,695,915.56 for the replacement of the Stearns School Road at Mill Creek triple barrel culverts with a single span bridge structure, appropriating \$2,035,000 of County Option Motor Fuel Tax funds.

- There was a public call for bids, and a total of five bids were received, ranging from \$1,695,915.56 to \$2,270,410.53, and the lowest responsible bidder is Rausch Infrastructure. LLC, Des Plaines, Illinois, in the amount of \$1,695,915.56.
- This improvement is included in the Transportation Improvement Program with construction in 2023, and designated as Section 20-00235-02-BR.

RESOLUTION

WHEREAS, pursuant to authority granted by this Lake County Board, the County Engineer heretofore called for sealed bids, by publication, for the replacement of the Stearns School Road at Mill Creek triple barrel culverts with a single span bridge structure, and designated as Section 20-00235-02-BR; and

WHEREAS, pursuant to said publication calling for said bid, sealed bids were received and

opened on February 7, 2023, at 10:00 a.m. at the Lake County Division of Transportation in Libertyville, Illinois; a tabulation of said bids being as follows:

Rausch Infrastructure, LLC Des Plaines, Illinois \$1,695,915.56

Lorig Construction Company Des Plaines, Illinois \$1,706,065.16

Alliance Contractors, Inc. Woodstock, Illinois \$1,874,109.34

F.H. Paschen, S.N. Nielsen & Associates LLC Chicago, Illinois \$1,981,197.26

Areatha Construction Co., Inc. Streamwood, Illinois \$2,270,410.53

WHEREAS, the Public Works and Transportation Committee, the County Engineer and the Purchasing Agent have examined each bid, and it appears that the lowest responsible bidder is Rausch Infrastructure, LLC, Des Plaines, Illinois, their bid being \$1,695,915.56 based on estimated quantities and unit prices; and

WHEREAS, an appropriation of funds is required.

NOW, THEREFORE, BE IT RESOLVED, by this Lake County Board, that a contract be awarded to said Rausch Infrastructure, LLC, Des Plaines, Illinois, in accordance with their bid of \$1,695,915.56 based on estimated quantities and unit prices, and that the County Purchasing Agent, the County Clerk, and the County Engineer of Lake County be authorized, and they are hereby directed to enter into a contract with said low bidder for the replacement of the Stearns School Road at Mill Creek triple barrel culverts with a single span bridge structure, and designated as Section 20-00235-02-BR.

BE IT FURTHER RESOLVED, that in as much as such estimated quantities are the best approximation that can be determined at this time, these quantities may be added to, deducted from, or modified from in the final determination of the contract cost in accordance with Chapter 605 of the Illinois Compiled Statutes, Act 5, Section 5-205.2 without further Board action, providing the final cost chargeable to the funds appropriated does not exceed the appropriation.

BE IT FURTHER RESOLVED, that there is hereby appropriated \$2,035,000 of County Option Motor Fuel Tax funds.
