Special recognition of May 7, 2023 through May 13, 2023 as National Correctional Officers Week.

### SPECIAL RECOGNITION

**WHEREAS**, introduced and approved by the 98<sup>th</sup> United States Congress, as Senate Joint Resolution 132 to honor correctional officers and correctional personnel nationwide, May 7 through May 13, 2023, is designated as National Correctional Officers Week; and

**WHEREAS**, correctional officers are responsible for the supervision of individuals arrested, convicted, and/or sentenced for criminal offenses. The supervision of such individuals takes place in the Lake County Adult Correctional Facility, including the Community-Based Correctional Center offering Periodic Imprisonment and Electronic Home Monitoring; and

**WHEREAS**, the Lake County Adult Correctional Facility protects the public by housing individuals who have committed criminal offenses and keeping them separate from the community; and

**WHEREAS**, preparing individuals for reintegration into the community is critical in protecting the public's safety. The Lake County Adult Correctional Facility partners with outside agencies such as the Lake County Health Department, and non-profit, educational, and faith-based organizations to provide inmate programming and mentoring services to ensure a successful re-entry into the community; and

**WHEREAS**, a career in corrections is challenging. Corrections personnel must maintain a constant state of heightened vigilance, adhere to strict security protocols, and perform their duties with the threat of exposure to violent events; and

**WHEREAS**, the dedication and courage of our corrections personnel were especially highlighted during the COVID-19 pandemic, as specific protocols and mitigation strategies were implemented to protect the health and safety of those in custody as well as corrections personnel.

**NOW, THEREFORE, BE IT RECOGNIZED**, by this County Board of Lake County, Illinois that Lake County proclaims May 7, 2023 through May 13, 2023, as National Correctional Officers Week; and

**BE IT FURTHER RECOGNIZED**, that this Lake County Board does hereby thank the 167 dedicated professionals in the Lake County Sheriff's Adult Correctional Facility and Community-Based Correctional Center for their professionalism, dedication and courage.
