Resolution approving 3.5.FY24 Fiscal Year 2024 Budget Planning Guidance which provides County Board guidance for the preparation of the Fiscal Year (FY) 2024 annual budget.

- Each year, the County Board provides guidance for development of the annual budget.
 Guidance that is updated annually is found in Policy 3.5FYxx which is intended to provide parameters or guidelines for a specific fiscal year.
- Policies 3.5 Budget Development Policy and 3.6 Budget Execution Policy provide fundamental policy that is reviewed annually but only updated as necessary.
- The guidance provided through this process includes direction regarding the property tax levy, employee salary increases, new program requests, contributions to capital, environmentally sustainable alternatives, and other direction.
- A draft Guidance document was presented on April 27, 2023 along with a presentation including background financial information at the Financial and Administrative Committee. If these guidelines are approved on May 9, the FY 2024 budget preparation process will begin with departments in mid-May.
- An amendment was made at the May 4, 2023, Financial and Administrative Committee
 meeting to strengthen the sustainability language in 5.1.6 to incorporate net zero goals and to
 require departments to provide sustainable options and alternatives in their budget
 submissions, rather than encouraging them to do so.
