Ordinance providing for the reappointments of Jennifer Clark as Director and John Wasik as Alternate Director of the Central Lake County Joint Action Water Agency.

### ORDINANCE

**WHEREAS**, per the 5 ILCS 220/3.1 Municipal Joint Action Water Agency it is required that the Director and Alternate Director of any joint action water agency must be appointed by Ordinance; and

**WHEREAS**, by the terms of an Ordinance approving the Central Lake County Joint Action Water Agency and the Central Lake County Joint Action Water Agency Agreement, it is necessary to reappoint a Director and Alternate Director to serve said Agency as representatives of Lake County; and

**WHEREAS**, the term for Jennifer Clark as Director and John Wasik as Alternate Director of the Central Lake County Joint Action Water Agency have expired; and

**WHEREAS**, your Chair requests that this County Board confirm the reappointment of Jennifer Clark as Director and John Wasik as Alternate Director of the Central Lake County Joint Action Water Agency with terms beginning immediately and ending Wednesday, April 30, 2025.

**NOW, THEREFORE, BE IT ORDAINED**, by this County Board of Lake County, Illinois, that Jennifer Clark is hereby reappointed to serve as Director and John Wasik as Alternate Director of the Central Lake County Joint Action Water Agency for a term beginning

immediately and ending Wednesday, April 30, 2025, as set forth in the Central Lake County Joint Action Water Agency Agreement.
