Resolution authorizing a contract with Yellowstone Landscape, Wauconda, Illinois, for Lawncare and Landscape Services for Lake County Facilities in the estimated annual amount of \$95,291.

- The current contract for Lawncare and Landscape Services has expired with no options for renewal.
- The County received six bids for Lake County Facilities in the amounts of \$49,380 through \$138,574.14, one non-responsive bid was received.
- Yellowstone Landscape, Wauconda, Illinois is the lowest responsible and responsive bidder in the estimated annual amount of \$95,291.
- This resolution authorizes a two-year contract with Yellowstone Landscape, Wauconda, Illinois with three one-year renewals for an estimated annual amount of \$95,291.

### RESOLUTION

**WHEREAS**, there is a need to enter into a contract for lawncare and landscape services for Lake County Facilities; and

**WHEREAS**, in accordance with the Lake County Purchasing Ordinance, proposals were called for by publication for lawncare and landscape services for various Lake County departments; and

**WHEREAS**, electronic bids were received from six vendors and publicly opened on July 24, 2024, at 11:00 a.m.; and

**WHEREAS**, based on the criteria set forth in the bid; the staff evaluated all bids submitted and determined that the bid submitted by Yellowstone Landscape, Wauconda, Illinois, in the amount of \$95,291 is the lowest responsible and responsive bidder for Lake County Facilities.

**NOW, THEREFORE, BE IT RESOLVED**, by this County Board of Lake County, Illinois, that the Purchasing Agent is authorized to enter into a contract with Yellowstone Landscape, Wauconda, Illinois, for Lawncare and Landscape Service for Lake County Facilities in the estimated annual amount of \$95,291.
