Joint resolution ratifying an emergency purchase with Pathway Health Services Inc. for interim staffing services at Winchester House in the amount of \$550,000.

- Since December 2010 five key positions at Winchester House became vacant due to resignations or retirements.
- Vacant positions include: MDS Coordinator, Director of Nursing and Clinical Coordinator.
- In accordance with Article 6-103 of the Lake County Purchasing Ordinance, the Winchester House Administrator certified an emergency condition and the Purchasing Agent executed an interim staffing agreement.
- Positions are paid only for hours worked.
- Ratification of the emergency purchase is required for interim staffing from December 2010 through September 30, 2011.

**WHEREAS**, there was a need to secure interim nursing management positions of Director of Nursing, two MDS Coordinators and two Clinical Coordinators due to staff vacancies; and

**WHEREAS**, Pathway Health Services, INC., 2025 4<sup>th</sup> Street, White Bear Lake, MN provided a proposal to staff these positions on an interim basis; and

**WHEREAS**, in accordance with Article 6-103 of the Lake County Purchasing Ordinance, the Winchester House Administrator certified that an emergency condition exists; and

**WHEREAS**, the Purchasing Agent executed an interim staffing agreements.

**NOW, THEREFORE, BE IT RESOLVED**, by this County Board of Lake County, Illinois that the

Emergency Procurement authorized by the Winchester House Administrator with Pathway Health Services, INC., 2025 4<sup>th</sup> Street, White Bear Lake, MN in the estimated amount of \$550,000 charged to account 218-4101010-71150 is ratified.
