Joint resolution authorizing execution of a contract with Insituform Technologies USA, Inc, in the amount of \$299,255.50 for the Sanitary Sewer Rehabilitation 2011 Project.

- The County undertakes annual rehabilitation of deteriorating and aging sanitary sewer systems.
- The 2011 sewer rehabilitation project includes relining and spot repair to approximately 6,600 feet of sewers in the Grandwood Park System.
- The County received bids from three (3) contractors for this work.
- Award of this contract is recommended to the lowest responsive, responsible bidder, Insituform Technologies USA, Inc., Chesterfield, Mo in the amount of \$299,255.50.
- Two (2) other bids were received, ranging from \$303,058 to \$333,771.50.
- This resolution authorizes execution of a contract with Insituform Technologies USA, Inc. in the amount of \$299,255.50 for the Sanitary Sewer Rehabilitation 2011 Project.

RESOLUTION

WHEREAS, the County of Lake (County) owns, operates and maintains several sanitary sewer systems within the County; and

WHEREAS, these sanitary sewer systems are prone to deterioration and failure due to age and require rehabilitation and repair; and

WHEREAS, in accordance with Section 4-102 of the Lake County Purchasing Ordinance, bids were called for by publication for the Sanitary Sewer Rehabilitation 2011 Project; and

WHEREAS, subsequent to said publication, invitations to bid were extended to twenty (20)

contractors; and

WHEREAS, three (3) sealed bids were received and publicly opened in the office of the Public Works Department on Monday, July 25, 2011, at 2:00 p.m., and

WHEREAS, Insituform Technologies USA, Inc. is the lowest responsive and responsible bidder in the amount of \$299,255.50; two (2) other bids were received, ranging from \$303,058.00 to \$333,771.50.

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Purchasing Agent is hereby authorized and directed to execute a contract with Insituform Technologies USA, Inc., Chesterfield, MO in the amount of \$ 299,255.50 for the Sanitary Sewer Rehabilitation 2011 Project and charging the costs thereof to Account No. 610-4843698-48310.
