Joint resolution accepting the Illinois Department of Commerce and Economic Opportunity (DCEO) Trade Adjustment and Assistance Act grant and authorizing an emergency appropriation of \$31,201.

- The Illinois Department of Commerce and Economic Opportunity has provided a grant under the Trade Adjustment and Assistance Act to the Lake County Workforce Development Department in the amount of \$31,201.
- The grant is for federal fiscal year July 1, 2011 to September 30, 2012.
- This funding will reimburse Lake County for costs associated with providing training to individuals eligible under the act.
- An emergency appropriation of \$31,201 is requested to be approved to allocate these funds into the Workforce Department's budget and authorize acceptance of this grant.

**WHEREAS**, The Illinois Department of Commerce and Economic Opportunity has provided a grant under the Trade Adjustment and Assistance Act to the Lake County Workforce Development Department and,

WHEREAS, the grant for Lake County Workforce Development is \$31,201 and

WHEREAS, this grant is for the fiscal year July 1, 2011 to September 30, 2012; and

**WHEREAS,** this funding will reimburse Lake County for costs associated with providing training to individuals eligible under the act;

WHEREAS, it is necessary to approve an emergency appropriation of \$31,201 to allocate these

funds into the Workforce Department budget and authorize acceptance of this grant.

**NOW, THEREFORE, BE IT RESOLVED,** by this County Board of Lake County, Illinois, that an emergency appropriation in the amount of \$31,201 for the Workforce Development Department is hereby approved and that the Trade Adjustment and Assistance Act Grant be accepted. A chart of accounts will be provided to the Controller in a timely manner.
