Joint resolution appropriating \$2,543,000 of Matching Tax funds, \$2,227,500 of Motor Fuel Tax funds and \$5,929,500 of ¼% for Transportation and Public Safety Tax funds for the reconstruction and widening of Delany Road, from York House Road to Wadsworth Road, and designated as Section 00-00093-18-WR.

### RESOLUTION

**WHEREAS**, Delany Road, County Highway 22, is a designated route on the county highway system; and

**WHEREAS**, it would be beneficial to the safety and welfare of the motoring public if Delany Road could be improved by reconstruction, widening, installation of permanent traffic control signals, and construction of detention areas; and

**WHEREAS**, plans, specifications and estimates of costs for this improvement have been completed, and this improvement is now ready to proceed to contract letting; and

**WHEREAS**, before a construction letting can be held, an appropriation of funds is needed.

**NOW, THEREFORE BE IT RESOLVED** by this Lake County Board that there is hereby appropriated \$2,543,000 of Matching Tax funds, \$2,227,500 of Motor Fuel Tax funds and \$5,929,500 of ¼% for Transportation and Public Safety Tax funds for the reconstruction and widening of Delany Road, from York House Road to Wadsworth Road, and designated as Section 00-00093-18-WR.

**BE IT FURTHER RESOLVED** that this appropriation be processed by the County Engineer for final approval of the Illinois Department of Transportation in accordance with the "Agreement of Understanding" between the Illinois Department of Transportation and Lake County, dated January 22, 2003.
