Joint resolution authorizing a contract with Chicagoland Paving, Inc., Lake Zurich, Illinois, in the amount of \$75,929.54, for the overlaying of existing pavement with hot mix asphalt (HMA) surface course and cutting back butt joints on various Waukegan Township Road District streets, and designated as Section 16-16000-01-GM.

- 2016 Waukegan Township Road District: Contract Award.
- A total of three bids were received, ranging from \$75,929.54 to \$86,277.54, with Chicagoland Paving, Inc., Lake Zurich, Illinois, being the lowest responsible bidder with a contract amount of \$75,929.54.

RESOLUTION

WHEREAS, pursuant to authority granted by this Lake County Board and the Waukegan Township Road District Highway Commissioner, the County Engineer heretofore called for sealed bids, by publication, for the overlaying of existing pavement with HMA surface course and cutting back butt joints on various Waukegan Township Road District streets in the Waukegan Township Road District, and designated as Section 16-16000-01-GM; and

WHEREAS, pursuant to said publication and calling for said bids, sealed bids were received and opened on May 17, 2016, at 10:00 A.M. at the Lake County Division of Transportation in Libertyville, Illinois, a tabulation of said bids being as follows:

Chicagoland Paving Inc. Lake Zurich, Illinois \$75,929.54

Payne & Dolan, Inc. Antioch, Illinois \$79,404.92

Peter Baker & Son Company Lake Bluff, Illinois \$86,277.54

WHEREAS, the Public Works and Transportation Committee, the County Engineer and the Purchasing Agent have examined each bid, and it appears that the lowest responsible bidder is Chicagoland Paving, Inc., Lake Zurich, Illinois, their bid being \$75,929.54, based on estimated quantities and unit prices; and

NOW, THEREFORE BE IT RESOLVED by this Lake County Board, that a contract be awarded to said Chicagoland Paving, Inc., Lake Zurich, Illinois, in accordance with their bid of \$75,929.54, based on estimated quantities and unit prices, and that the Purchasing Agent, the County Clerk, and the

County Engineer of Lake County be authorized and they are hereby directed to enter into a contract with said low bidder for overlaying of existing pavement with HMA surface course and cutting back butt joints on various Waukegan Township Road District streets, and designated as Section 16-16000 -01-GM.

BE IT FURTHER RESOLVED that in as much as such estimated quantities are the best approximation that can be determined at this time, these quantities may be added to, deducted from, or modified from in the final determination of the contract cost in accordance with Chapter 605 of the Illinois Compiled Statutes, Act 5, Section 5-205.2 and Section 6-701.1 without further Board action.

BE IT FURTHER RESOLVED that this contract award be processed by the County Engineer for final approval of the Illinois Department of Transportation in accordance with the "Agreement of Understanding" between the Illinois Department of Transportation and Lake County, dated January 18, 2013, and subject to the approval of the Waukegan Township Road District Highway Commissioner.
