## **Legislation Text**

Joint resolution authorizing a contract with Peter Baker & Son Company, Lake Bluff, Illinois, in the amount of \$55,731 for the overlay of existing pavement with Hot-Mix Asphalt (HMA) and surface course on various streets in the Waukegan Township Road District, and designated as Section 17-16000-01-GM.

- 2017 Waukegan Township Road District: Contract Award.
- A total of five bids were received, ranging from \$55,731 to \$77,900, with Peter Baker & Son Company, Lake Bluff, Illinois, being the lowest responsible bidder with a contract amount of \$55,731.
- This project is included in the highway improvement program.

## RESOLUTION

**WHEREAS**, pursuant to authority granted by this Lake County Board and the Waukegan Township Road District Highway Commissioner, the County Engineer heretofore called for sealed bids, by publication, for the overlay of existing pavement with HMA and Surface Course on various streets in the Waukegan Township Road District, and designated as Section 17-16000-01-GM; and

**WHEREAS,** pursuant to said publication and calling for said bids, sealed bids were received and opened on March 21, 2017, at 10:00 A.M. at the Lake County Division of Transportation in Libertyville, Illinois, a tabulation of said bids being as follows:

Schroeder Asphalt Services, Inc. Huntley, Illinois \$65,605.44

Payne & Dolan, Inc. Antioch, Illinois \$66,408.44

J.A. Johnson Paving Company Arlington Heights, Illinois \$72,906.94

**WHEREAS**, the Public Works and Transportation Committee, the County Engineer and the Purchasing Agent have examined each bid, and it appears that the lowest responsible bidder is Peter Baker & Son Company, Lake Bluff, Illinois, their bid being \$55,731 based on estimated quantities and unit prices; and

**NOW, THEREFORE BE IT RESOLVED** by this Lake County Board, that a contract be awarded to said Peter Baker & Son Company, Lake Bluff, Illinois, in accordance with their bid of \$55,731 based on estimated quantities and unit prices, and that the Purchasing Agent, the County Clerk, and the County Engineer of Lake County be authorized and they are hereby directed to enter into a contract with said low bidder for the overlay of existing pavement with HMA and surface course on various streets in the Waukegan Township Road District, and designated as Section 17-16000-01-GM.

**BE IT FURTHER RESOLVED** that in as much as such estimated quantities are the best approximation that can be determined at this time, these quantities may be added to, deducted from, or modified from in the final determination of the contract cost in accordance with Chapter 605 of the Illinois Compiled Statutes, Act 5, Section 5-205.2 and Section 6-701.1 without further Board action.

**BE IT FURTHER RESOLVED** that this award be processed by the County Engineer for final approval of the Illinois Department of Transportation in accordance with the "Agreement of Understanding" between the Illinois Department of Transportation and Lake County, dated January 18, 2013, and subject to the approval of the Waukegan Township Road District Highway Commissioner.
