## Legislation Text

Ordinance amending the Lake County Comprehensive Stormwater Management Plan to include the Des Plaines River Watershed-Based Plan.

- Stormwater Management Commission (SMC) worked with numerous watershed stakeholders to develop the watershed-based plan for the Des Plaines River Watershed; including 39 municipalities, 15 townships, Lake County, and the Des Plaines River Watershed Workgroup.
- SMC held a 30-day public review period for the draft watershed-based plan report that included a public hearing (April 27, 2018 in Waukegan) and a public information meeting (April 12, 2018 in Libertyville).
- SMC adopted the Des Plaines River Watershed-Based Plan as an Amendment to the Lake County Comprehensive Stormwater Management Plan on October 4, 2018.

## ORDINANCE

**WHEREAS**, the County Board of Lake County in enabling the SMC statutory authority has an adopted Lake County Comprehensive Stormwater Management Plan, and said plan recommends the development of comprehensive watershed management plans for each of Lake County's 26 subwatersheds; and

**WHEREAS**, the Lake County Stormwater Management Commission has been working to revise and update the comprehensive watershed plan to include the Des Plaines River Watershed-Based Plan hereinafter referred to as "Watershed-Based Plan"; and

**WHEREAS**, the purpose of the Watershed-Based Plan is to improve degraded conditions in the Des Plaines River watershed by improving water quality, reducing flood damage, and protecting and enhancing natural resources through implementing best management practices and programs and providing resources and information for watershed communities to integrate multi-objective watershed management in their decision-making activities; and

**WHEREAS**, the adoption of the Watershed-Based Plan is necessary for the successful implementation of a series of individual site-specific projects and watershed-wide programmatic actions to: improve water quality, reduce flood damage potential, protect and enhance natural resources, provide watershed education opportunities, and improve community cooperation and participation in watershed improvement activities; and

**WHEREAS**, all public hearing and meeting requirements have been met in the preparation of the Watershed-Based Plan; and

**WHEREAS,** a 30-day comment period; which included outreach and coordination with the general public has been accomplished; and

**WHEREAS**, the Lake County Stormwater Management Commission approved the Des Plaines River Watershed-Based Plan on October 4, 2018;

**NOW, THEREFORE, BE IT ORDAINED,** by the County Board of Lake County, Illinois, that the Des Plaines River Watershed-Based Plan is hereby adopted as an Amendment to the Lake County Comprehensive Stormwater Management Plan, in accordance with 55 ILCS 5/5-1062; and

**BE IT FURTHER ORDAINED** that a copy of the final Des Plaines River Watershed-Based Plan will be sent to each municipality and township in the Des Plaines River Watershed.
