Joint resolution appropriating \$760,100 of Motor Fuel Tax funds for maintaining streets and highways, including utility services, under the applicable Illinois Highway Code, from December 1, 2019, to November 30, 2020, and \$200,000 of Matching Tax funds.

- In order to perform routine and necessary highway maintenance, the Division of Transportation must purchase Patrol One general maintenance materials and services.
- Patrol One general maintenance materials and services may include, but not be limited to, supplies such as paint, signposts, shoulder aggregate, and deicing materials, as well as utility services and repairs.
- This project is included in the highway improvement program, and is designated as Section 20-00000-00-GM.

### **RESOLUTION**

**WHEREAS**, to maintain the condition of the designated routes on the County highway system, the Division of Transportation annually undertakes various general maintenance activities that utilize miscellaneous highway materials and services; and

**WHEREAS**, general maintenance materials and services may include, but not limited to, supplies such as paint, signposts, shoulder aggregate, and deicing materials, as well as utility services and repairs; and

**WHEREAS**, the estimated cost of the general maintenance materials and services for 2020 is estimated to be \$960,100.

**NOW, THEREFORE BE IT RESOLVED** by this Lake County Board, that there is hereby appropriated \$760,100 of Motor Fuel Tax funds for maintaining streets and highways, including utility services, under the applicable Illinois Highway Code, from December 1, 2019, to November 30, 2020, and \$200,000 of Matching Tax funds for deicing materials needed to support various maintenance activities on various County highways, and designated as Section 20-00000-00-GM.

**BE IT FURTHER RESOLVED**, that only those operations as listed and described on the approved Estimate of Maintenance Costs, including supplemental and revising estimates approved in connection with this resolution, are eligible for maintenance with Motor Fuel Tax funds during the period as specified above.

**BE IT FURTHER RESOLVED** that the County Engineer of Lake County shall submit within

three months after the end of the maintenance period as stated above, to the Illinois Department of Transportation, on forms available from the Department, a certified statement showing expenditures and the balances remaining in the funds authorized for expenditure by the Department under this appropriation.

**BE IT FURTHER RESOLVED**, that the Lake County Clerk is hereby directed to transmit four certified originals of this resolution to the district office of the Illinois Department of Transportation.

**BE IT FURTHER RESOLVED**, that this appropriation be processed by the County Engineer for final approval of the Illinois Department of Transportation in accordance with the "Agreement of Understanding" between the Illinois Department of Transportation and Lake County, dated May 3, 2018.
