## Legislation Text

Joint resolution authorizing a contract with Chicagoland Paving, Inc., Lake Zurich, Illinois, in the amount of \$350,000 for annual hot-mix asphalt maintenance of various roads on the County highway system and appropriating \$420,000 of Matching Tax funds.

- Lake County's Hot-Mix Asphalt Patching Program is an annual preventive maintenance program that preserves the surface quality and extends the life of County highways.
- There was a public call for bids, and a total of four bids were received, ranging from \$350,000 to \$674,874.12. Chicagoland Paving, Inc. was identified as the lowest responsible bidder in the amount of \$350,000.
- This project is included in the highway improvement program with construction in 2020, and designated as Section 20-0000-13-GM.

## RESOLUTION

**WHEREAS**, pursuant to authority granted by this Lake County Board, the County Engineer heretofore called for sealed bids, by publication, for annual hot-mix asphalt maintenance of various roads on the County highway system, and designated as Section 20-00000-13-GM; and

**WHEREAS**, pursuant to said publication and calling for said bids, sealed bids were received and opened on March 17, 2020, at 10:00 a.m. at the Lake County Division of Transportation in Libertyville, Illinois; a tabulation of said bids being as follows:

Chicagoland Paving, Inc. Lake Zurich, Illinois \$350,000

J.A. Johnson Paving Company Arlington Heights, Illinois \$376.688.88

Peter Baker and Son Company Lake Bluff, Illinois \$447,758.88

**WHEREAS**, the Public Works, Planning and Transportation Committee, the County Engineer, and the Purchasing Agent have examined each bid, and it appears that the lowest responsible bidder is Chicagoland Paving, Inc., Lake Zurich, Illinois, in the amount of \$350,000, based on estimated quantities and unit prices; and

WHEREAS, an appropriation of funds is required.

**NOW, THEREFORE BE IT RESOLVED** by this Lake County Board, that a contract be awarded to said Chicagoland Paving, Inc., Lake Zurich, Illinois, in the amount of \$350,000, based on estimated quantities and unit prices, and that the Purchasing Agent, the County Clerk, and the County Engineer of Lake County be authorized and they are hereby directed to enter into a contract with said low bidder for annual hot-mix asphalt maintenance of various roads on the County highway system, and designated as Section 20-00000-13-GM.

**BE IT FURTHER RESOLVED** that in as much as such estimated quantities are the best approximation that can be determined at this time, these quantities may be added to, deducted from, or modified from in the final determination of the contract cost in accordance with Chapter 605 of the Illinois Compiled Statutes, Act 5, Section 5-205.2 without further Board action, providing the final cost chargeable to the funds appropriated does not exceed the appropriation.

**BE IT FURTHER RESOLVED** that there is hereby appropriated \$420,000 of Matching Tax funds.
